ORDER

Before **PHILLIPS** and **EBEL**, Circuit Judges.

This matter is before the court on Plaintiffs-Appellants' November 4, 2013, Emergency Motion for Injunction Pending Appeal. Defendants-Appellees are hereby ordered to respond to Plaintiffs-Appellants' motion by Thursday, November 7, 2013, by or before 9:00 a.m. MST. Plaintiffs-Appellants are ordered to reply to Defendants-Appellees' response by Friday, November 8, 2013, by or before 5:00 p.m. MST.

Further, in order to provide the court adequate time to consider the matter, we hereby issue a temporary stay of the district court's November 1, 2013, memorandum opinion and order, and we grant temporary injunctive relief pending further order of this court:

1. The Federal Defendants-Appellees are enjoined from dispatching inspectors to the horse slaughterhouse facilities operated by Valley Meat Company, LLC; Responsible Transportation, LLC; and Rains Natural Meats.

2. The Federal Defendants-Appellees are ordered to suspend or withhold the provision of horse meat inspection services to Valley Meat Company, LLC; Responsible Transportation, LLC; and Rains Natural Meats.
